# **PUBLIC HEARING**

## Rezoning of Properties on Pine Grove, Lane, Sunshine, and Bryan:

# ANNOUNCEMENT OF QUORUM

City Clerk Heather Tooley called the roll. Mayor Adam Webb opened the meeting of the Board of Aldermen at 5:32 pm with a quorum present. Invocation was led by Jeff Conger.

## **AGENDA APPROVAL**

## **CONSENT AGENDA**

Motion by Alderman Rich, second by Alderman Owens to approve the Consent Agenda as presented which included Approval of Minutes – (RM 10/16, SM 10/23), Approval of Bills for Payment, Receipt of Financial Reports, and YMCA, Department Head's & Board's Reports. Motion carried 4-0.

#### **VISITORS**

Amanda Mendez: Council was approached by Amanda Mendez with a Public Purpose Statement pursuant to Ordinance No. 1599 for funds to complete the Bailey Legacy Park, which highlights the lifetime achievements of Wendell Bailey. Mendez stated that there will also be a walking path to promote tourism and shopping in downtown Willow Springs. Further discussion was held regarding fundraising efforts, ongoing maintenance, and insurance costs.

Motion by Alderman Rich, second by Alderman Owens to donate \$5,000.00 to the project and loan up to \$10,000.00 to be repaid on terms to be later determined and obtaining public easement or perpetual public use. Motion carried 4-0.

# **EXISTING BUSINESS**

**2026 Budget Discussion:** City Administrator Beverly Hicks gave a brief presentation regarding the 2026 draft budget in the amount of \$8,240,500.00. Hicks briefly discussed revenue adjustments, the COLA (Cost of Living Adjustment) in the amount of 2.8%, and other expenditures. A final draft will be presented to Council for official vote in December.

<u>City Marshal:</u> Both City Administrator Beverly Hicks and City Attorney Zane Privette discussed taking the matter to the voters to get rid of the position properly. A proposed ordinance will be presented in the December meeting for an official vote.
