City of Mountain Grove Proposition U

Shall the City of Mountain Grove impose a local use tax at the same rate as the total sales tax rate, provided that if the local sales tax rate is reduced or raised by voter approval, the local use tax rate shall also be reduced or raised by the same action?

If this proposition is approved, the City's General Fund Sales Tax rate will be reduced by one-eighth of one percent ($1/8\%$), lowering it from one percent (1.00%) to seven-eighths of one percent ($7/8\%$), and there-by reducing the total local sales tax rate from three percent (3.00%) to two and seven-eighths percent (2.875%). The reduction shall become effective concurrently with the effective date of the local use tax.
