Notice is hereby given that the General Municipal Election will be held in the County of Howell on Tuesday, April 7, 2026 as certified to this office by the participating entities of Howell County. The ballot for the Election shall be in substantially the following form.

**PROPOSITION 1**

Shall Howell County repeal its existing countywide capital improvement sales tax of one half of one percent (1/2 of 1%), authorized by Section 67.700 of the Revised Statutes of Missouri and approved for the purpose of road maintenance and materials, and impose a countywide sales tax of one half of one percent (1/2 of 1%), authorized by Section 67.547 of the Revised Statutes of Missouri, for the purpose of maintaining, constructing, and improving county-maintained roads and bridges?

*Approval of this proposition will not increase the sales tax rate in Howell County*

PROPOSITION FLYERS**

Shall the Board of Education of the Fairview R-XI School District, Missouri, borrow money in the amount of Five Million Dollars (\$5,000,000) for the purpose of providing funds for the site development, construction, equipping, and furnishing of a new gymnasium; to complete the expansion of several classrooms; to the extent funds are available, complete other repairs and improvements to the existing facilities of the District; and issue general obligation bonds for the payment thereof resulting in an estimated increase to the debt service property tax levy of \$0.5700 per one hundred dollars of assessed valuation? If this proposition is approved, the adjusted debt service levy of the School District is estimated to increase from \$0.0000 to \$0.5700 per one hundred dollars of assessed valuation of real and personal property.

Shall the Board of Education of the Oregon-Howell R-III School District, Missouri, without an estimated increase in the current debt service property tax levy, borrow money in the amount of Six Hundred Fifty Thousand Dollars (\$650,000) for the purpose of providing funds to repair and/or replace heating, ventilation, and air conditioning (HVAC) systems District-wide; to complete asphalt parking lot maintenance; to the extent funds are available, complete other repairs and improvements to the existing facilities of the District; and issue general obligation bonds for the payment thereof? If this proposition is approved, the adjusted debt service levy of the School District is estimated to remain unchanged at \$0.8000 per one hundred dollars of assessed valuation of real and personal property.
