PROPOSITION K.I.D.S.

Shall the Board of Education of the Houston R-1 School District, Missouri, without an estimated increase in the current debt service property tax levy, borrow money in the amount of Two Million Nine Hundred Fifty Thousand Dollars (\$2,950,000) for the purpose of providing funds to renovate, construct, equip, and furnish a new track and natural field at the current location to include additional accessibility measures; to renovate the Middle School gymnasium and exterior of the Fine Arts Building; to pay off the Piney River Technical Center lease financing; to the extent funds are available, complete other repairs and improvements to the existing facilities of the District; and issue general obligations bonds for the payment thereof?

If this proposition is approved, the adjusted debt service levy of the School District is estimated to remain unchanged at \$0.8000 per one hundred dollars of assessed valuation of real and personal property.

PROPOSITION U
<i>Shall the City of Mountain Grove impose a local use tax at the same rate as the total sales tax rate, provided that if the local sales tax rate is reduced or raised by voter approval, the local use tax rate shall also be reduced or raised by the same action?</i>
If this proposition is approved, the City's General Fund Sales Tax rate will be reduced by one-eighth of one percent (1/8%), lowering it from (1.00%) to seven-eighths of one percent (7/8%), and there-by reducing the total local sales tax rate from three percent (3.00%) to two and seven-eighths percent (2.875%). The reduction shall become effective concurrently with the effective date of the local use tax.
If a majority of the votes cast on the proposal are in favor of the question the use tax shall become effective on the first day of the third calendar quarter (July 1, 2026) after the Director of Revenue receives notice of adoption from the City.
